Any Yamhill County school faculty member or trade-related educator of grades 6-12 is eligible to apply for grant funds, a total of 3 grants will be awarded each year.

#### **Grant Criteria Includes:**

- a completed application with supporting documentation
  - a follow up report after funds have been spent (in-person or written submission)

- After the grant proposal is reviewed by Cruising McMinnville, membership will discuss the proposal. The faculty advisor will receive notification of the decision within 60 days of application submission.
- Grants can be made as a reimbursement or direct payment to vendor with proper documentation. Receipts, invoices or other official documentation must be presented for funds to be received. Please work with Cruising McMinnville Treasurer to receive your funds.
- Grant decisions are constrained by the amount of available funds and are considered in the order applications are received.
